

Assistant Professor, Teaching Stream – Theoretical Foundations of Social Justice Education (Part-Time Term Appointment)

The Department of Social Justice Education at the Ontario Institute for Studies in Education (OISE), University of Toronto invites applications for a part-time (75%) two-year term appointment at the rank of **Assistant Professor**, **Teaching Stream**, **specializing in Theoretical Foundations of Social Justice Education**, with an anticipated start date of July 1, 2025. Applicants must have a Ph.D. or equivalent doctoral degree by the time of appointment. Relevant areas of specialization and fields of study may include but are not limited to: critical theory (eg. Frankfurt School, post-structuralism, etc.), cultural sociology, critical pedagogy, feminist theory, Indigenous spiritualities and epistemologies, decoloniality, anti-colonial theory, environmental justice, transnationalism/globalization, migration studies, middle-eastern studies, Islamic studies, East Asian studies, disability or mad studies, childhood and youth studies, cultural or media studies.

Candidates must have a demonstrated record of excellence in teaching, as well as teaching experience in a degree-granting graduate program, including working with masters and/or doctoral students in an advisory or supervisory role (e.g. committee member, examiner, supervisor, chair, etc.). Additionally, candidates must possess a demonstrated commitment to excellent pedagogical inquiry and a demonstrated interest in teaching-related scholarly activities. We seek candidates whose teaching and professional interests complement and enhance our existing <u>departmental strengths</u>. We are particularly interested in applications from individuals whose work is rooted in anti-racist, decolonial/anticolonial, feminist/womanist, and other critical perspectives on and approaches to theory in social justice education.

Candidates will be expected to teach graduate courses on conceptual and theoretical foundations, as well as courses that are part of the Social Justice Education graduate programs. In addition, the candidate will teach other courses as needed in the curriculum and that match the candidate's areas of substantive expertise. Other responsibilities of the position include departmental service (including departmental committee work as assigned) and strategic initiatives, and it is expected that the successful candidate will work effectively, respectfully, and collaboratively in diverse and inclusive settings committed to social justice and equity.

Salary will be commensurate with qualifications and experience.

The Department of Social Justice Education offers MA, MEd, PhD, and EdD degrees in Social Justice Education in addition to participating in several collaborative specializations. Social Justice Education has long been a banner for expansive conversations in critical education taking place across the globe. Our department meaningfully contributes to these broader conversations while also maintaining a distinctive place in the field through our interdisciplinary and multidisciplinary focus in the humanities and social sciences.
